

**TOWN OF VAUXHALL
BYLAW NO 904-16
RATES BYLAW**

BEING A BYLAW OF THE TOWN OF VAUXHALL, IN THE PROVINCE OF ALBERTA, TO ESTABLISH SERVICE FEES IN THE TOWN OF VAUXHALL

WHEREAS the *Municipal Government Act* (Alberta, R.S.A. 2000, Chapter M-26, and amendments thereto) provides for Council to pass and enforce bylaws for municipal purposes respecting the safety, health and welfare of the people and the protection of people and property;

AND WHEREAS the *Municipal Government Act* (Alberta, R.S.A. 2000, Chapter M-26, and amendments thereto) provides for Council to pass and enforce bylaws for the municipal purposes respecting services provided by or on behalf of the municipality;

AND WHEREAS the *Municipal Government Act* (Alberta, R.S.A. 2000, Chapter M-26, and amendments thereto) provides that a Council, by bylaw, may establish fees;

AND WHEREAS Council wants to adopt a Schedule of Fees;

AND WHEREAS Council deems it expedient from time to time to revise the Schedule of Fees for Municipal services,

NOW THEREFORE the Council of the Town of Vauxhall enacts as follows;

1. NAME OF BYLAW

This bylaw may be cited as the "Rates Bylaw"

2. INTENTION OF TOWN COUNCIL

It is the intention of the Town Council that each separate provision of this Bylaw shall be deemed independent of all other provisions herein and it is further the intention of the Town Council that if any provision of the Bylaw be declared invalid, all other provisions thereof shall remain valid and enforceable.

3. RESCINDED OR AMENDED BYLAW

Bylaw No. 889-15 is hereby repealed in it's entirety.


4. This Bylaw shall take effect on the day of the final passing and the signatures of the chief elected official and duly authorized designated officer thereof.

5. EFFECTIVE DATE

READ A FIRST TIME IN COUNCIL THIS 2nd DAY OF May, 2016.

READ A SECOND TIME IN COUNCIL THIS 16th DAY OF May, 2016

READ A THIRD TIME IN COUNCIL AND FINALLY PASSED THIS 16th DAY OF May, 2016

**Schedule of Fees for Utility Services

Installation

The Town of Vauxhall will install water and sewer on request to individual lots. Each request will be treated separately and an estimate will be provided based on the following:

- a) Material – cost plus 10% overhead and 10% profit
- b) Contracted cost – cost plus 10% overhead and 10% profit
- c) Equipment rental – as per Alberta Road Builders Association posted rates
- d) Man hours – hourly rate plus overhead (UI, CPP, Benefits) and 10% profit
- e) Road and sidewalk damage will be added to the cost of installation

The water will not be turned on until payment of the installation fee has been made to the Town of Vauxhall.

Collection of Rates

The rates shall be due and payable when rendered and a penalty of 2.7% will be charged on all current amounts, which are not paid by the due date.
