BY-LAW NO. 909-16

A BY-LAW OF THE TOWN OF VAUXHALL IN THE PROVINCE OF ALBERTA

"MUNICIPAL EMERGENCY MANAGEMENT BYLAW"

WHEREAS the Council of the Town of Vauxhall is responsible for the direction and control of its emergency response and is required, under the Emergency Management Act, Chapter E-6.8, Revised Statutes of Alberta 2000 (current as of June 19, 2007), to appoint an Emergency Management Committee and to establish and maintain a Municipal Emergency Management Agency; and

WHEREAS it is desirable in the public interest, and in the interests of public safety, that such a committee be appointed and such an agency be established and maintained to carry out Council's statutory powers and obligations under the said Emergency Management Act;

NOW, THEREFORE, THE COUNCIL OF THE TOWN OF VAUXHALL, DULY ASSEMBLED, ENACTS AS FOLLOWS:

- 1. This By-law may be cited as the Municipal Emergency Management By-law.
- 2. In this By-law,
 - (a) "Act" means the Emergency Management Act, Chapter E-6.8, Revised Statutes of Alberta 2000;
 - (b) "Council" means the Council of the Town of Vauxhall;
 - (c) "Disaster" means an event that has resulted or may result in serious harm to the safety, health or welfare of people, or in widespread damage to property;
 - (d) "Emergency Management Committee" means the committee established under this By-law;
 - (e) "Emergency" means a present or imminent event that requires prompt co-ordination of action or special regulation of persons or property to protect the health, safety or welfare of people or to limit damage to property;
 - (f) "Minister" means the Minister charged with administration of the Act;
 - (g) "Municipal Emergency Management Agency" means the agency established under this Bylaw: and
 - (h) "Municipal Emergency Plan" means the emergency plan prepared by the Director of Emergency Management to co-ordinate response to an emergency or disaster and includes the Intermunicipal emergency services plan adopted as part of the Regional Emergency Management Framework Agreement with the Municipal District of Taber.

- 3. There is hereby established an Emergency Management Committee to advise Council on the development of emergency plans and programs.
- There is hereby established a Municipal Emergency Management Agency to act as the agent of Council to carry out its statutory powers and obligations under the Act. This does not include the power to declare, renew, or terminate a state of local emergency, nor the powers contained in Section 12 of this By-law.

Council shall

- (a) by resolution, appoint its members to serve on the Emergency Management Committee;
- (b) provide for the payment of expenses of the members of the Emergency Management Committee:
- (c) by resolution, on the recommendation of the Emergency Management Committee, appoint a Director of Emergency Management and a Deputy Director of Emergency Management who shall do those things required of the Director of Emergency Management in that person's absence;
- (d) ensure that emergency plans and programs are prepared to address potential emergencies or disasters in the Town of Vauxhall;
- (e) approve the Town of Vauxhall emergency plans and programs; and
- (f) review the status of the Municipal Emergency Plan and related plans and programs at least once each year.

6. Council may

- (a) by By-law borrow, levy, appropriate and expend, without the consent of the electors, all sums required for the operation of the Municipal Emergency Management Agency; and
- (b) enter into agreements with and make payments or grants, or both, to persons or organizations for the provision of services in the development or implementation of emergency plans or programs, including mutual aid plans, Intermunicipal emergency services plans, and programs.
- 7. The Town of Vauxhall Emergency Management Agency shall be comprised of one or more of the following:
 - (a) Council;
 - (b) the Director of Emergency Management;
 - (c) the Deputy Director of Emergency Management;
 - (d) the Municipal Administrator;
 - (e) designated officers of the municipality;
 - (f) any other individuals who Council deems necessary to mitigate an emergency.

- 8. The Municipal District of Taber and the Town of Vauxhall may establish at any time a Joint Municipal Emergency Management Agency and shall be comprised of one or more of the following:
 - (a) Council members appointed by the Town of Vauxhall and the Municipal District of Taber;
 - (b) the Director of Emergency Management appointed by the municipalities;
 - (c) the Deputy Director of Emergency Management appointed by the municipalities;
 - (d) the Municipal Administrators from each of the municipalities;
 - (e) designated officers of the municipalities;
 - (f) any other individuals who the Agency deems necessary to mitigate an emergency.
- 9. A Joint Municipal Emergency Management Agency established by the Municipal District of Taber and the Town of Vauxhall shall:
 - (a) Jointly appoint a Director of Emergency Management and a Deputy Director of Emergency Management
 - (b) Through the Director of Emergency Management and the Deputy Director of Emergency Management administer the joint municipal emergency plan
 - (c) Meet annually to discuss matters related to the joint municipal emergency plan
 - (d) Meet to exercise the plan
 - (e) Seek ways to collaborate regionally on matters related to joint municipal emergency planning
- 10. The Director of Emergency Management shall
 - (a) prepare and co-ordinate the Municipal Emergency Plan and related plans and programs for the Municipal District of Taber and the Town of Vauxhall as a joint plan,
 - (b) act as director of emergency operations, or ensure that someone is designated under the Municipal Emergency Plan to so act, on behalf of the Municipal Emergency Management Agency established by the Municipal District of Taber and the Town of Vauxhall; and
 - (c) co-ordinate all emergency services and other resources used in an emergency; or
 - (d) ensure that someone is designated to discharge the responsibilities specified in paragraphs (a), (b), and (c).
- 11. The Town of Vauxhall and the Municipal District of Taber may only declare a State of Local Emergency within their own jurisdictions in accordance with the Emergency Management Act.
- 12. The power to declare or renew a state of local emergency under the Act, the powers specified in Section 11 of this By-law, and the requirement specified in Section 14 of this By-law, are hereby delegated to a committee comprised of the Reeve, or in his absence the Deputy Reeve, and any two other members of Council. This committee may at any time when it is satisfied that an emergency exists or may exist make a declaration of a state of local emergency.

- 13. When a state of local emergency is declared the declaration shall
 - (a) ensure that the declaration identifies the nature of the emergency and the area of the Town of Vauxhall in which it exists;
 - (b) cause the details of the declaration to be published immediately by such means of communication considered most likely to notify the population of the area affected; and
 - (c) forward a copy of the declaration to the Minister forthwith.
- 14. Subject to Section 14, when a state of local emergency is declared, the person making the declaration may
 - (a) cause the Municipal Emergency Plan or any related plans or programs to be put into operation;
 - (b) acquire or utilize any real or personal property considered necessary to prevent, combat or alleviate the effects of an emergency or disaster;
 - (c) authorize or require any qualified person to render aid of a type he or she is qualified to provide;
 - (d) control or prohibit travel to or from any area of the Town of Vauxhall;
 - (e) provide for the restoration of essential facilities and the distribution of essential supplies and provide, maintain and co-ordinate emergency medical, welfare and other essential services in any part of the Town of Vauxhall;
 - (f) cause the evacuation of persons and the removal of livestock and personal property from any area of the Town of Vauxhall that is or may be affected by a disaster and make arrangements for the adequate care and protection of those persons or livestock and of the personal property;
 - (g) authorize the entry into any building or on any land, without warrant, by any person in the course of implementing an emergency plan or program;
 - (h) cause the demolition or removal of any trees, structures or crops if the demolition or removal is necessary or appropriate in order to reach the scene of a disaster, or to attempt to forestall its occurrence or to combat its progress;
 - (i) procure or fix prices for food, clothing, fuel, equipment, medical supplies, or other essential supplies and the use of any property, services, resources or equipment within the Municipal District of Taber for the duration of the state of emergency;
 - (j) authorize the conscription of persons needed to meet an emergency; and
 - (k) authorize any persons at any time to exercise, in the operation of the Municipal Emergency Plan and related plans or programs, any power specified in Paragraphs (b) through (j) in relation to any part of the municipality affected by a declaration of a state of local emergency.
- 15. When a state of local emergency is declared,
 - (a) neither Council nor any member of Council, and
 - (b) no person appointed by Council to carry out measures relating to emergencies or disasters,

are liable in respect of damage caused through any action taken under this By-law, nor are they subject to any proceedings by prohibition, certiorari, mandamus or injunction.

-)16. Notwithstanding Section 12,
 - (a) Council and any member of Council, and
 - (b) any person acting under the direction or authorization of Council, is not liable for negligence in carrying out their duties under this By-law.
- 17. When, in the opinion of the person declaring the state of local emergency, an emergency no longer exists in relation to which the declaration was made, they shall, by resolution, terminate the declaration.
- 18. A declaration of a state of local emergency is considered terminated and ceases to be of any force or effect when
 - (a) a resolution is passed under Section 14;
 - (b) a period of seven days has lapsed since it was declared, unless it is renewed by resolution;
 - (c) the Lieutenant Governor in Council makes an order for a state of emergency under the Act, relating to the same area; or
 - (d) the Minister cancels the state of local emergency.
- 19. When a declaration of a state of local emergency has been terminated, the person who made the declaration shall cause the details of the termination to be published immediately by such means of communication considered most likely to notify the population of the area affected.
- 17. Bylaw No. 851-11 is hereby rescinded upon 3rd reading of this bylaw.

This Bylaw comes into force on the day it is finally passed.
