## 2023 Property Tax Bylaw No. 994-23

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE TOWN OF VAUXHALL FOR THE 2023 TAXATION YEAR.

WHEREAS, the Town of Vauxhall has prepared and adopted detailed estimates of municipal revenue, expenses and expenditures as required, at the council meeting held on January 17, 2023.

WHEREAS, the estimated municipal revenues from all sources other than property taxation total \$2,061,676 and:

WHEREAS, the estimated municipal expense (excluding non-cash items) set out in the annual budget for the Town of Vauxhall for 2023 total \$2,787,932 and the balance of \$726,256 is to be raised by general municipal property taxation; and

WHEREAS, the estimated amount required to repay principal debt to be raised by general taxation is \$55,404 and;

WHEREAS, the estimated amount required for current year capital expenditures to be raised by general municipal taxation is \$155,000 and;

THEREFORE the total amount to be raised by general municipal taxation is \$936,660 and
