A person who contravenes s.147.4 and who fails to comply within 30 days of the time provided and pay the municipality a late filing fee of \$500 is guilty of an offence and liable to a fine of not more than \$5,000.

INSTRUCTIONS

- 1. Enter the contact information for the staff member of the local jurisdiction responsible for FOIP matters.
- 2. Enter the complete and official name of the local jurisdiction for which the election was conducted.
- 3. The candidate enters the calendar vear of disclosure. (Note: The campaign period is four years and each year is reported separately).
- 4. The candidate enters their name as it was entered on the written notice submitted in accordance with s.147,22 or on the Nomination Form.
- 5. The candidate enters their complete mailing address and postal code.
