Criminal Code Offences



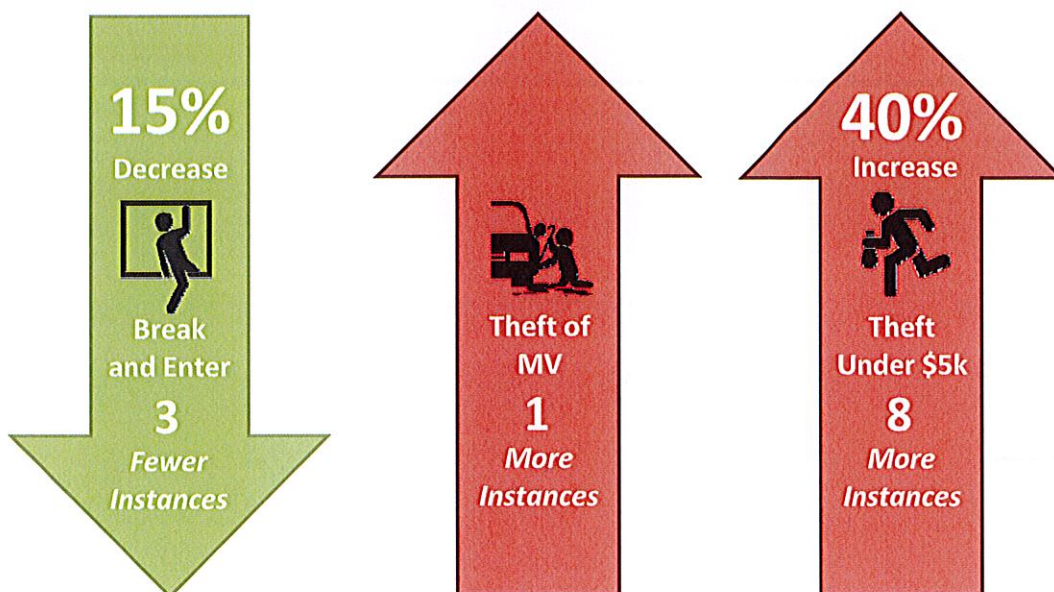

Detachment Commander's Comments

- The Detachment laid charges in five criminal investigations during the month of October.
- Property Crime from October was as follows: There were three reports of Break and Enter one to a solar farm, one to a remote oil lease site, and another to an outbuilding on a farm. Charges were laid in the B&E to the farm.

There was one Frauds reported.

There were two reports of Mischief. Both were in regards to people gathering at the Chamberlain School after hours, and leaving a mess. The culprits were identified; however, the school district did not wish to pursue charges. The people involved were warned to no longer gather at the school after hours. This will also be monitored during patrols.

There were three reports of Theft. One is still under investigation, while the other was cleared using Restorative Justice.

- In what was undoubtedly a highlight of my 20-year career, I was invited to swear in the new MD of Taber Council during their organizational meeting October 28th.

**Taber (Provincial) Crime Statistic Summary – January to October****2025/11/04*****Taber (Provincial) – Highlights***

- **Break & Enters** are showing a 15.0% decrease when compared to the same period in 2024 (January to October). There were 3 fewer actual occurrences (from 20 in 2024 to 17 in 2025).
- **Theft of Motor Vehicles** increased by 7.1% when compared to the same period in 2024 (January to October). There were 1 more actual occurrences (from 14 in 2024 to 15 in 2025).
- **Theft Under \$5,000** increased by 40.0% when compared to the same period in 2024 (January to October). There were 8 more actual occurrences (from 20 in 2024 to 28 in 2025).

From January to October 2025, when compared to the same period in 2024, there have been:

- 30 more **Persons Crime** offences;
- 19 more **Property Crime** offences; and
- 49 more **Total Criminal Code** offences;

Taber (Provincial) – October, 2025

- There were 0 **Thefts of Motor Vehicles** in October: 0 cars, 0 trucks, 0 minivans, 0 SUVs, 0 motorcycles, 0 other types of vehicles, and 0 vehicles taken without consent.
- There were 3 **Break and Enters** in October: 3 businesses, 0 residences, 0 cottages/seasonal residences, 0 in some other type of location, and 0 unlawfully being in a dwelling house.
- There were a total of 0 **Provincial Roadside Suspensions** in October (0 alcohol related and 0 drug related). This brings the year-to-date total to 4 (4 alcohol related and 0 drug related).
- There were a total of 5 files with the **Spousal Abuse** survey code in October (October 2024: 6). This brings the year-to-date total to 47 (2024: 30).
- There were 102 files with **Victim Service Unit** referral scoring in Taber Provincial: 4 accepted, 1 declined, 0 proactive, 0 requested but not available, and 97 files with no victim.
